It looks like the warm weather of spring has finally arrived. The birds are coming back, spring flowers are beginning to bloom, and the WTA has several new things to introduce as well!

The Health Care Buyout Option: If you currently purchase 2 Person, Family NS, or a Family health-care plan from the district please strongly consider the proposed healthcare buyout of \$3,250. We need approximately 25 people to take the buyout in addition to the other 32 people who already do not purchase healthcare from the district. To see if the buyout would financially be a benefit to you add the price of the health care plan that you would purchase next year to the \$3,250 buyout amount.

For example: next year's Blue Point 2 (\$5 family NS) costs \$1,449, if you add that to the buyout amount of \$3,250 it equals \$4,699. If your spouse's employer offers a similar plan for less you stand to save money. Please consider taking the buyout even if you only will save a small amount of money as it may enable your fellow WTA members to save a significant amount of money depending on their situation.

VOTE –COPE Needs You! We will be starting our VOTE-COPE drive on May 14. We are asking all of our members to sign up for a paycheck deduction of at least 1 dollar per pay period for the 2007-2008 school year as well as make a small one-time donation for the current school year through a

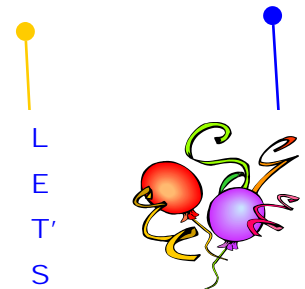
check made out to VOTE-COPE.

Jason Carter: Health Care Buy Out! — The Supplemental Benefits Committee (SBC) has researched the concept of the Healthcare Buyout.
